***Sec. 14-438. - Regulation of portable on-site storage units.**

The use of portable, on-site storage units within the village shall be as follows:

Residential property:

One unit per property is allowed with a permit from the village. An additional unit will be allowed after obtaining a permit and paying a fee, the amount of which will be set from time-to-time by resolution of the village board.

Permits are valid for 30 days. A 90 day permit may be issued for one unit if the unit is used during the time a permit issued by the village for work on the property is in effect.

Permits will not be issued for any property unless one year has passed from the date any previous permit expired.

Commercial, manufacturing and industrial property.

Units are prohibited unless a permit is requested for use during the time a permit issued by the village for work on the property is in effect. The length of the permit will be based upon the permitted work among other factors. An application and fee shall be required. The permit fee amount will be set from time-to-time by resolution of the village board.

THIS PERMIT IS ISSUED WITH THE EXPRESS CONDITIONS THAT THE GRANTEE WILL OBEY ALL ORDINANCES OF THE VILLAGE OF WEST MILWAUKEE, AND ALL RULES AND REGULATIONS OF THE MUNICIPAL CODE RELATIVE TO THE PURPOSE FOR WHICH SAID PERMIT IS ISSUED. IT IS HEREBY PROVIDED THAT THE GRANTEE WILL ERECT BARRIERS AND LIGHTS TO PREVENT THE HAPPENING OF ANY ACCIDENTS OR DAMAGES, IN CONSEQUENCE OF THE GRANTING OF SAID PERMIT. THE GRANTEE FURTHER AGREES TO THE VILLAGE OF WEST MILWAUKEE HARMLESS IN CASE OF THE HAPPENING OF ANY ACCIDENTS OR THE ACCOUNT OF ANY DAMAGES ARISING THROUGH ISSUANCE OF THIS PERMIT. THE VILLAGE RESERVES THE RIGHT TO REVOKE THIS PERMIT AT ANY TIME IF IT IS IN THE BEST INTEREST OF THE VILLAGE OF WEST MILWAUKEE.

THE ACCEPTANCE OF THIS PERMIT BY THE GRANTEE CONSTITUTES AN ACKNOWLEDGEMENT AND ACCEPTANCE OF THE CONDITIONS AND REGULATIONS AS HEREIN NOTED.
