HALLOWEEN SAFETY FOR YOUR PETS

Time for your annual Halloween reminder to keep your pet safe this Halloween! These quick tips will help you avoid pet related scares:

- Candy is NOT for dogs and cats! Many of us already know that chocolate can be deadly to dogs, but you also must watch for xylitol, a common sugar substitute found in sugar free candy and gum which can also be deadly for your pets.
- Open doors are tempting to many pets – make sure your pet has a collar on with an ID tag with your current contact information
- Candles are dangerous to leave around your pets, even inside of a jack-o-lantern. Many fires are started by candles knocked over by a curious pet. Burns are also common when pets get too close to a flame.
- If you have a naturally shy or fearful dog or cat, it is best to leave them secured in a room or closed off by a baby gate in a safe area during trick-or-treating.
- If you are taking your dog along for trick-or-treating, make sure they are wearing a secure collar and leash and that any costume fits properly and is not pinching or causing difficulty breathing or walking.
- Do not leave your dog or cat outside on Halloween night, with so many children out and about, dogs tend to get over stimulated and bark at passers-by. It is always better to keep them safely indoors until the next day when things are quieted down.

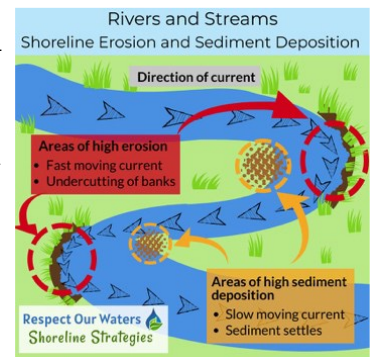
RESPECT OUR WATERS

Both lakes and rivers undergo shoreline erosion, however, their processes and system dynamics differ. Some of the major factors influencing river shoreline erosion are the volume and speed of the current, and the integrity and composition of the shoreline banks.

Due to the continuous movement of the water, rivers and streams are constantly changing shape. This also means that sediment is stripped from the shoreline continually and is transported downstream. Areas with slow-moving currents experience sediment deposition, well areas with fast-moving currents experience strong erosion.

Bank shores with exposed soil surfaces and little to no vegetation are highly susceptible to undermining, causing major chunks of soil to fall into the stream. Infrastructure close to these areas can easily destabilize. This can lead to clogs in the river, making localized flooding a severe issue during major rain events. An eroding streambank can be a significant source of sediment pollution.

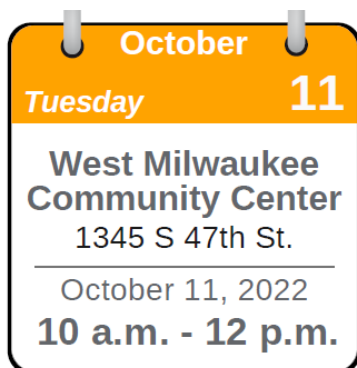

Following submittal to the Clerk's Office of a completed Application for an Absentee Ballot or submittal of a request for an Absentee Ballot through My Vote Wisconsin, registered voters can receive a ballot in the mail or can vote in person at the Village Clerk's Office.

NOTE: Regular voters must provide a valid photo ID along with their request if one is not on file with your voter registration.

It is the policy of the Village of West Milwaukee to assure equal opportunity to live in adequate housing facilities regardless of race, color, religion, ancestry, national origin, sex, handicap, sexual preference, marital status of persons maintaining a household, lawful source of income, place of birth, or age, and to prohibit discrimination in housing by any persons.

In connection with any real estate transaction which affects any housing accommodation on the open market, or in connection with any public sale, purchase, rental or lease of any accommodation, it is illegal within West Milwaukee for a person, owner, financial institution, real estate broker or sales representative to:

1. Refuse to sell, purchase, rent or lease to a person because of race, color, religion, ancestry, national origin, handicap, marital status, sexual preference, sex, age, or place of birth.
2. To discriminate against a person in the terms, conditions or privileges on the sale, purchase, rental or lease of any housing accommodation.

Any person who has a complaint, or who may be aggrieved by any unlawful practice which is prohibited by the Village ordinance (50-30) or State Statute (106.50), may file a complaint after the alleged unlawful practice has occurred. In addition to the local Code of Ordinances, an individual can pursue complaints under both State and Federal Fair Housing Laws. If a person chooses to pursue a complaint through a Federal Administrative Agency, the complaint must be filed with the Department of Housing and Urban Development (HUD) within one year of the last act of discrimination under the 1968 Federal Fair Housing Act (FFHA). To file a Federal Court Action under the FFHA one must file the complaint within two years of the act of discrimination. In addition, under the Civil Rights Act of 1866, which only applies to racial discrimination, a person has up to three years to file a judicial complaint. Additional contact telephone numbers for complaints include the Metropolitan Milwaukee Fair Housing Council (414-278-1240), the United States Department of Housing and Urban Development (414-297-3214, Ext. 8300 or 8301), or the State of Wisconsin Equal Rights Division (414-227-4384).

Absentee By-Mail:

Absentee ballots will be sent by mail to those registered voters with a completed application on file. You will receive your ballot in the mail with a self-addressed stamped envelope for return, along with instructions. Vote your ballot, sign and date your certificate envelope, have a witness sign your certificate envelope including their complete address, and return it to the Village Clerk's Office by mail or personally deliver your own absentee ballot directly to the Village Clerk's Office at West Milwaukee Village Hall, 4755 West Beloit Road. Use of the Village Hall drop box is NOT permitted by State law. Currently, State law requires that absentee ballots must be returned to the Village Clerk's Office prior to 8 p.m. on Election Day. The USPS recommends allowing at least one week for your absentee ballot to be delivered to the Village Clerk's Office. Once there is only a week remaining before an Election to return your ballot, voters are strongly encouraged to personally deliver your own ballot to the Village Clerk's Office.

Absentee voting in the Village Clerk's office is restricted to the 2 weeks before an Election and ends at the close of business the Friday before an Election. **THE CLERK'S OFFICE HOURS FOR IN-PERSON ABSENTEE VOTING - 8:00 A.M. TO 4:30 P.M. MONDAY THRU FRIDAY, WITH HOURS ON THURSDAY, NOVEMBER 3 AND FRIDAY, NOVEMBER 4, 2022, 8:00 A.M. TO 5 P.M.**

Voter Registration:

To avoid long lines, or possible or possible lack of required registration documentation by those who have not previously done so and are planning on registering at the polling locations on Election Day, we encourage eligible voters to register to vote prior to an Election. Voters already registered in the Village of West Milwaukee are also encouraged to contact the Village Clerk's Office if your name has changed or you have moved within West Milwaukee since you last voted in West Milwaukee. Check your current registration information by contacting the West Milwaukee Clerk's Office or access the information directly at MyVoteWisconsin. Residents that are not registered to vote in the Village of West Milwaukee can register online at MyVoteWisconsin or fill out the Voter Registration Application, which includes a section for changing information such as your name or address, and return it to the Village Clerk's office. Qualified voters can register on Election Day at their correct polling location. Valid proof of residency is required, and the requirement for residing in a municipality prior to an Election is 28 consecutive days.

Voter Registration Deadlines:

October 19, 2022 — The deadline to register to vote online or by-mail (postmarked).

November 4, 2022 5pm — The deadline to register to vote at your clerk's office or other designated location.

You can register at your polling place on Election Day.

Receiving a Tax Statement

Property tax statements are typically mailed by the second full week in December. The bills are mailed to the owner of record per the Milwaukee County Registrar of Deeds unless an official mailing address change has been made at the Village Clerk's office or Assessor's office prior to November 15. If you do not receive a tax bill by December 15, the tax bill can be obtained online.

To have your 2022 taxes marked paid in 2022, payments must be received in our office on or before December 29, 2022. Make sure you are aware of the holidays that we are closed for business, to alleviate any problems when paying your taxes.

You Can Use the Property Tax Portal to:

- Access your tax bill or balance
- Make a tax payment, includes user fees
- Obtain and print your tax bill
- Obtain and print your tax summary, which shows balance due and payments made
- See the receipt for your property tax payment

Due Dates

- Pay in full by January 31. (Real Estate and Personal Property Bills)
- Pay in three interest-free installments for Real Estate Bills by January 31, April 30, and July 31.

Preparing the Payment

- Include your tax bill.
- Make checks payable to the Village of West Milwaukee and write your tax parcel number in the memo area of your check.
- If you pay with an escrow check from your mortgage company, you need to endorse the check. If it is made out to another municipality, you will have to return it and have a replacement check made.

Pay by Mail

- Pay by mail using the return envelope that came in your tax bill.
- Address your envelope to Village of West Milwaukee, 4755 W. Beloit Rd. West Milwaukee, WI 53214.
- For payment due dates, the receipt date for timely mailed payments will be the date on the U.S. Postal Service postmark.

- Pay online at www.westmilwaukee.org through the tax portal for an additional fee.

- Online from the property tax portal
- By contacting our office at (414) 645-1530 ext. 0
- Immediately if you pay in person.

TAX REFUNDS

There is a minimum fifteen (15) day waiting period for a refund check. Should you wish to have a refund in a more expedient manner, you may request that your financial institute issue one check for the actual amount due for taxes and another check to your for the remaining balance. Any refunds under \$5.00 will have to be picked up in person.

Personal Property Taxes

The Village must be notified of any and all changes to businesses. We must be notified if a business moves out so we can change the name and address of the property that needs to receive the personal property bills and the statement of personal property form.

In January, the assessor will send out the statement of personal property form for each business to report their amount of personal property. This must be completed and returned to the assessor's office by March 1st of each year. If this is not reported and we are not notified of any changes, the assessor will figure the taxes accordingly based on the prior year's taxes and you will continue to receive personal property tax bills.

ADOPT-A-HYDRANT PROGRAM

As the snow begins to fall, please help the Fire Department by adopting the fire hydrant closest to your home or business and keep it free of snow.

Please make it a point to uncover your fire hydrant after each and every snowfall. Clear a path approximately 3 feet around the hydrant and shovel a 3-foot path from the road to the fire hydrant. Should the need arise, these actions will allow the Fire Department to quickly locate the fire hydrant, obtain a water supply for firefighting activities, and give the Fire Department room to work around the hydrant.

Please consider helping a neighbor in need of assistance by shoveling out a hydrant in front of their home. This act of kindness will benefit the entire neighborhood that the hydrant services.

A fire engine/pumper carries enough water on board for approximately 2 to 3 minutes of firefighting. In the event of a fire, the Fire Department must quickly locate and gain a water supply from the closest fire hydrant. If a fire hydrant is buried by snow, valuable time must be spent locating the hydrant and digging it out. It may take from 4 to 6 minutes to dig out a fire hydrant buried by snow. The delay in gaining a water supply from a fire hydrant may disrupt the timely manner in which firefighters are able to fight the fire and way allow a fire to grow. Fire doubles in size approximately every 18 seconds.

The Adopt-A-Hydrant Program is an informal program; therefore, it is not necessary to advise the Fire Department which hydrants you will be clearing snow from.

SNOW REMOVAL

Do not blow snow onto the street, alley or other Village right-of-way at any time. Try to find off street parking whenever there is snow accumulation. Vehicles parked on both sides of the street make it very difficult for a plow to pass and service the street. Clear out adequate space for your garbage/recycling containers on your collection day. If you are concerned about snow removal at your property, you may wish to contact.
