VILLAGE PRESIDENT'S REPORT

President Stalewski reported that Employ Milwaukee will be hosting a workforce summit on September 20th and requested that anyone interested in attending, let him know.

West Milwaukee Community Development Authority (WMCDA) REPORT

Chairperson Schaefer reported that there is a May meeting scheduled where discussion regarding a TID proposal will take place. Administrator Egan requested a meeting with Chairperson Schaefer, President Stalewski and the Village financial advisors be scheduled prior to the CDA meeting to prepare.

DEPARTMENT HEAD UPDATES

Clerk/Treasurer Susan Schupp reported that liquor license renewals have become more of a challenge. Many organizations did not complete the renewal process until long after the April deadline. However, she stated that the organizations have all paid the newly implemented inspection fee.

Trustee Ragonese suggested that Clerk/Treasurer Schupp maintain a strict deadline for the liquor license renewals and hold the businesses accountable. There was a brief discussion suggesting less assistance from the Village and if renewals are not received by the deadline the liquor licenses will not be renewed.

VILLAGE ADMINISTRATOR'S REPORT

Administrator Egan reported that the West Allis IT contract goes through 2024 however, the West Allis Health Department contract ends at the end of 2023. West Allis will provide the Village with an updated contract that will be on an upcoming agenda. Administrator Egan noted the annual Health Department report, number three (3) in the packet. The Health Department noted an exceptional relationship with Cermak Fresh Market. The Health Department hosted on-site COVID vaccination clinics at Cermak Fresh Market and awarded the business with a Friend of Public Health Award.

Plan Commission met on Tuesday, May 9, 2023, and approved updates to signage and exterior improvements at Gordon Foods and Walmart. Taco Johns was approved for a monument sign.

Administrator Egan asked that either Trustee Schaefer or Hill submit a write-up for the summer newsletter. CDBG contacted the Village stating that there may be additional funds available for Village projects. Administrator Egan suggested Community Center and Firehouse upgrades as potential projects. Trustee Schuettke mentioned it may be beneficial to name the lunch program as a beneficiary of additional block grant funding.

The Cop on a Rooftop fundraiser is scheduled for Friday, May 19, 2023, at Dunkin Donuts on Miller Park Way.

Administrator Egan inquired if the Board would like to open the time capsule at the July Beer Garden and if notification should be included in the summer newsletter. There was a consensus to open the time capsule at the July 20th Beer Garden and promote the event in the newsletter and at the June Beer Garden. Trustee Ragonese suggested a fundraising procedure to raise funds to erect the Froedtert Malt frieze and noted that the time capsule opening might draw people in that would be willing to donate to the cause. Trustee Schaefer suggested that the Village capitalize on the current publicity and use it to kick off a fundraising campaign. Trustee Schaefer explained he is working on putting together a model concept, depicting the plans for the historical items. It was also suggested that Froedtert Malt, the media and other related parties are invited to attend the time capsule opening.

There will be a discussion at the next meeting regarding the Board's feedback on a previously budgeted plow truck and squad car.
