VILLAGE ADMINISTRATOR'S REPORT

Administrator Egan reported that her and Administrative Assistant, Kayla Fitzgerald attended the annual VISIT Milwaukee meeting and will attend the WCMA Conference in Green Bay, Wednesday, June 21 through Friday, June 23rd. The Milwaukee County Department of Transportation (MCDOT) will conduct public outreach regarding the Complete Communities Transportation Planning Project at the Village of West Milwaukee National Night Out on August 18, 2023.

Plan Commission approved new signage for Hunger Task Force and Dry Hootch. Three (3) firework tents will be set up again this year. Stomper's Concrete came before the Plan Commission and are still lacking on completing conditions that were listed as part of the Planned Unit Development (PUD).

Community Development Block Grant (CDBG) announced that additional funding is available. The Village applied for new countertops and flooring at the Community Centre and new interior paint at the Firehouse. If asbestos abatement is required for the Community Centre flooring, we may only be able to complete the upper-level flooring. A new police officer has started and is currently in the training process.


